CLINIC LEVEL - 2.0

A person who has never played pickleball and would like to learn how to play the game.

BEGINNERS LEVEL - 2.0 - 2.5

A person who has never played pickleball before but played tennis/ping pong/badminton/racquet ball or paddleball and can hit the ball across the net and return the ball. A person who wants to play a fun and friendly game with others.

INTERMEDIATE LEVEL - 3.0 – 3.5

A person who has played pickleball before and can serve, return and dink the ball. Players of this level understand positioning and the rules of the game.

COMPETITIVE PLAYERS LEVEL - 3.5 - 5.0

A person who wants to compete in the "Competitive Tournament" is an active and very skilled pickleball player. They have full knowledge of the rules of the game and are able to play for hours should they advance with their individual score. Finalists will play in the Championship Tournament with other individual players with the highest score as a team of two.

THE PROBLEM:

- There are over 3,450 children and young adults under the jurisdiction of the Dependency Court in Orange County - which is overburdened and underfunded. The Dependency Court hears cases about children (minors) who are abused or neglected
- The average judge handles more than 800 cases per year; the average social worker carries up to 40 cases at one time, and an attorney may have over 100 cases at any moment
- 1 in 5 former youth in dependency will become homeless within one year of emancipating
- Only 58% of youth in dependency will graduate from high school
- Over 70% of the prison population is made up of people who were at one time in the dependency system
- By the age of 24, more than 50% of former youth in dependency will be unemployed





SINCE 1985...

- CASA OC has recruited and trained over 4,034 volunteers who have served as Court Appointed Special Advocates
- CASA OC has served over 9,047 youth in the dependency system
- 1.8 million hours volunteered by CASAs

THE SOLUTION:

- CASA volunteers provide the hope, inspiration and guidance that youth in the dependency system need to successfully overcome their abusive past and achieve a positive future
- CASA volunteers go through 34 hours of comprehensive training, background checks, and an extensive interview before becoming a sworn-in Court Appointed Special Advocate
- A child with a CASA volunteer is less likely to change placements
- Youth in the dependency system with a CASA have a 92% likelihood of graduating from high school
- Over 65,000 volunteer hours will be devoted to children in 2022 - saving nearly \$1.9 million in costs to the OC community
- More than 1,000 children in the OC dependency system will be served in 2022
